Dimension Research Inc. Established in 2018.

We, www.DimensionresearchInc.com, are responsible for processing personal data collected from or about you. For example, we collect your own information while assisting in statistical surveys, in business relationships, when you visit our website, or when you use our panel services. As we belong to the European Union, we process your own information in violation of relevant European information security laws and other laws and regulations.

What information do we collect?
